

QUALIFICATION CHECKLIST

Relating to Section 44 of the Constitution

EXPLANATORY NOTES

The advice below provides guidance on completing the qualification checklist. Key points:

- The completion or otherwise of the checklist is not grounds for rejecting a nomination.
- Candidates may consent to the AEC publishing their checklist on www.aec.gov.au.
- Candidates may also choose to provide additional documentation. The AEC will publish all additional documentation received on www.aec.gov.au, irrespective of whether or not a candidate consents to having their checklist published.
- Prior to submitting additional documentation to the AEC, candidates may redact, omit or delete any information that they do not want published, including the personal information of other individuals whose details may be included in the additional documentation.
- Candidates should not provide original documents, as the AEC is unable to return them. Documents must be provided in hard copy (i.e. no digital media). There is no requirement for copies of documents to be certified.
- No information or document, submitted as additional documentation, will be amended or removed from www.aec.gov.au once it has been published.
- Any information that is published on www.aec.gov.au will remain published until the time period for filing a petition disputing the election under section 355 of the *Commonwealth Electoral Act 1918* has expired.
- Candidates may choose to complete all, part or none of the checklist.
- For each candidate the AEC will publish:
 - whether or not the candidate submitted a checklist, and if they did, if they consented for it to be published; and
 - whether or not the candidate provided additional documentation.

Instructions for using the qualification checklist relating to section 44 of the Constitution

The qualification checklist relating to section 44 of the Constitution (the checklist) forms part of the candidate nomination form. Those seeking to nominate as a candidate may voluntarily complete the checklist to help demonstrate their eligibility to be elected to Parliament under section 44 of the Constitution. Candidates may choose to complete all, part or none of the checklist. The completion or otherwise of the checklist is not grounds for the relevant AEC Returning Officer to reject a nomination under section 172 of the *Commonwealth Electoral Act 1918* (the Electoral Act).

The AEC does not have the authority to determine the eligibility of any candidate on the basis of information provided in the checklist or any additional documentation.

A candidate may provide consent for the AEC to publish their checklist on www.aec.gov.au by signing their checklist where it states 'I agree to the Australian Electoral Commission publishing this checklist in its entirety'. If consent is provided, the candidate's checklist will be published on www.aec.gov.au as soon as practicable after the declaration of nominations. The checklist will remain published until the 40 day period for filing a petition disputing the election under section 355 of the Electoral Act has expired. Where a candidate does not provide consent, the checklist will not be published. Where a nomination is rejected under section 172 of the Electoral Act, the AEC will not publish the checklist or any documents in relation to that nomination.

Instructions for providing additional documentation

Candidates may choose to provide additional documentation to the AEC, together with their nomination form. This provides candidates with an opportunity to further demonstrate their eligibility to be elected to Parliament under section 44 of the Constitution. Candidates should not provide original documents, as the AEC is unable to return them. There is no requirement for copies of documents to be certified.

Any additional documentation received **will be published** on www.aec.gov.au as soon as practicable after the declaration of nominations, irrespective of whether consent has been provided to publish the checklist. Additional documentation will remain published until the period for filing a petition disputing the election under section 355 of the Electoral Act has expired.

Candidates can redact, omit or delete any information on the additional documentation that they do not want published on www.aec.gov.au. This includes consideration of the **personal information of other individuals** whose details may be included in the additional documentation.

It is a candidate's responsibility to carefully examine and redact, omit or delete any information they do not want published on www.aec.gov.au before submitting the additional documentation.

The AEC is required to publish **all** additional documentation exactly as provided. No information or document will be amended or removed from www.aec.gov.au once it has been published. Note that the AEC will not accept additional documentation provided on digital devices, such as DVDs, thumb/USB drives.

Note for each candidate the AEC will publish:

- whether or not the candidate submitted a checklist, and if they did, if they consented for it to be published; and
- whether or not the candidate provided additional documentation.
