Election Funding Claim

- Election funding is payable in relation to any candidate who received at least 4% of the total first preference votes cast in the election (calculated amount).
- Following the automatic payment of election funding of \$10,000 (indexed) a claim may be made for election funding of more than that amount using this form. The amount payable is the lesser of the calculated amount or the amount of demonstrated electoral expenditure incurred by the registered political party, a candidate or a member of a Senate group.
- This form can be completed with reference to the Election Funding Guide.
- This form must be lodged with the AEC no earlier than 20 days after polling day and no later than 6 months after polling day.
- This information is collected under section 297 of the Commonwealth Electoral Act 1918 (Electoral Act).
