Ltd.) and NPA (Vic) Settlement (tostee – Pilliwinks Pty. Ltd.) are not "associated entities" for the purposes of the Commonwealth Electoral Act. The Party rejects the proposition that the entities are operating to a significant extent for the benefit of the Party.

The Party has always disclosed information in relation to these entities because it has no reason to be concerned about their activities. However, the Party and the entities themselves would resist the categorisation as "associated entities" because that would have implications for the entities and might impose obligations on the entities, and more particularly, on the members, that are unreasonable and inappropriate.

he essential facts are:

NPA (Vic) Settlement is a trust conducted for the benefit of the members of the party. The Trust Deed could not be clearer in confirming this. Neither the trustee nor any other person or entity can affect the way in which income is distributed. The "relationship" between the trustee and the beneficiaries ceases once the income is distributed to the beneficiaries.
