Jeff -

Thanks for the catch-up.

We will await your formal advice regarding the AEC's preferred position of moving to postal vote only voting (i.e. dispensing with the mobile voting arrangements).

As discussed, it will be helpful to agree on a process for facilitating postal votes. It might, for example, be helpful to have a checklist that the prison uses to confirm for you that the prisoner is eligible (both in terms of sentence length and mental fitness).

We should also agree on processes where the prisoner is illiterate, cognitively impaired or non-English-speaking and may need assistance with completing the postal vote.

In my absence, either Brendan Money or Lisa Homatopoulos should be able to assist you.
