I have looked into this including checking with someone who has just today returned from leave.

Sure, the 2013 process has been complete for some time, and it was well publicised at the time that approx. 7,700 cases went forward as referrals from the AEC to the AFP etc. The AFP/CDPP did not undertake prosecutions after assessing the cases and the likelihood of successful prosecution before a court.

However, it appears that the AEC did not publish multiple voting data by electoral division for the 2013 federal election. (I have also checked the joint standing committee on electoral matters Australian Parliament House website pages pertaining the 2013 federal election.)

Hi Paul

Letters have been sent by the AEC to individuals where our comparisons of certified (voter) lists show an apparent multiple mark against that voter. It should be noted that those apparent multiple marks do not necessarily indicate 'multiple voting' - hence the process of contacting the elector. Consistent with AEC testimony provided last evening to Senate estimates I can provide a breakdown by state/territory for you, as shown below.

The AEC is currently part-way through a comprehensive process of seeking written responses to the letters and assessing them. This is also process undertaken with the involvement of the relevant AEC divisional returning officer.

For these reasons it is not appropriate to compile the data you seek midstream through a complex process.

The AEC will, however, provide submissions to the federal parliamentary Joint Standing Committee on Electoral Matters on the 2016 federal election, including regarding multiple voting, in due course. Submissions to the Committee are published on their website.
