**Re: Comments on the objections for the consideration of augmented Electoral Commission**

**1. Introduction**

1.1 The Liberal National Party (the Party) submits comments on the objections to the Queensland Redistribution Committee’s (QRC) proposed redistribution of Queensland into electoral divisions (proposed redistribution).

1.2 The Party has considered the objections to the proposed redistribution and submits the following comments for the consideration of the augmented Electoral Commission in determining the final boundaries. These comments are based on bringing communities of interest together, whilst minimising the impact on the QRC’s proposal, which we generally support.
