I note that in your draft changes to the NSW Electoral boundaries, published today (14/06/24) in the SMH, Epping / North Epping is to be shared between three Federal electorates: Bennelong, Parramatta & Berowra.

This change effectively disenfranchises Epping residents with respect to Federal issues as they relate to our suburb. Needing to approach and obtain consensus from three different Ministerial offices, potentially representing three different political factions.

We are being disposed of, politically!

All of Epping should be retained in a single Federal electorate, regardless of the political persuasion of it's representative.
