Submission by the Australian Labor Party (Tasmanian Branch) to the Redistribution Committee for Tasmania, 2025–26

The Australian Labor Party, Tasmanian Branch is pleased to endorse the following recommendations to the Redistribution Committee for Tasmania's consideration.

At this time Tasmanian Labor does not propose the renaming of any division of Tasmania and therefore this submission only deals with the boundaries of Tasmania's five electorates.

Contained in our recommendations are the following:

- a) The changes we propose and why they address the redistribution criteria outlined in section 73 of the *Commonwealth Electoral Act 1918*
- b) An Excel spreadsheet containing each SA1 in Tasmania, and which Division we propose for the SA1 to be in.
- c) A MapInfo TAB file.
- d) Visual maps to assist with clarity.

Summary

Tasmanian Labor submits that minimal changes are required to meet the projected enrolment quotas for 2030. The proposal retains existing community and administrative boundaries wherever possible, while making limited adjustments to Bass, Clark, Franklin, and Lyons to ensure equitable representation across Tasmania.

Braddon

As the electorate of Braddon is within the permissible range of both current and projected enrolment, **we recommend no change** to be made to Braddon.

No local government area within Braddon is currently divided by Commonwealth electorate boundaries. It is our strong view that there is no need to adjust these boundaries. Any alteration would unnecessarily introduce splits between local government areas that are presently contained wholly within a single division.

Bass

The electorate of Bass is outside the 3.5% range of projected enrolment quota by at least 780 electors to lift the projected enrolment quota from 80,818 to at least the lower permissible limit of 81,598.

It is Tasmanian Labor's submission that **the suburbs of Prospect Vale and Blackstone Heights should be returned to Bass**. Both suburbs were part of the electorate from Bass from the 1993 to the 2019 elections, primarily because of their urban integration with Launceston.

Despite being in the Meander Valley Local Government area both Prospect Vale and Blackstone Heights function as outer suburbs of Launceston. Residents commute into Launceston for work and services, meaning their economic and transportation patterns align with Bass rather than the more rural and vastly dispersed electorate of Lyons. The Bass Highway and Westbury Road provide direct, high frequency transport corridors into Launceston, reinforcing both suburbs inclusion in the Bass division.

The geographic border of Bass is clearly defined by the Blackstone Hills and Strahans Hill, creating a clear and identifiable boundary between the electorates of Bass and Lyons.

Additionally Tasmanian Labor suggests that the balance of SA1 60201105202 be transferred into the electorate of Bass, impacting just three electors and uniting all residents of Youngtown in Bass.

These changes represent an approach minimising the disruption of voters. Our submission will result in the electorate of Bass being well within both the actual and projected enrolment requirements.

Clark

The electorate of Clark is under the range of the projected enrolment quota by at least 5,909 electors.

It is Tasmanian Labor's submission that the boundary for the electorate of Clark be extended south to cover Kingston and Kingston Beach. This provides the most sensible way of transferring additional electors into Clark where residents of Kingston and Kingston Beach are part of the Kingborough Council which is already a local government area split between Clark and Franklin. Indeed, more than 1,200 residents of Kingston already reside within Clark.

Most notably the Southern Outlet directly links Kingston and Kingston Beach with central Hobart, under this proposal the whole of the Southern Outlet would be united in Clark.

Under this proposal the communities of Huntingfield and Maranoa Heights would remain in Franklin. The convergence of the Southern Outlet, Channel Highway and The Australian Antarctic Division provides the perfect path to demarcate the boundary between Clark and Franklin. Our proposal would see the boundary cut across to the southern end of the Boronia Hill Reserve as a natural buffer. The reserve between central Kingston and Maranoa Heights provides a clean, intuitive dividing line for the electorate boundary.

The natural boundary then flows down Jindabyne Road through to St Aloysius Catholic College and the Roslyn Avenue / Jindabyne Road roundabout where Boronia Beach and Blackmans Bay suburb boundary provides a natural vegetation buffer for which the boundary between Clark and Franklin can be drawn.

Franklin

The electorate of Franklin should be expanded into Old Beach whilst the southern boundary between Franklin and Clark should shift further south into Kingston.

Old Beach is an urban community on the Eastern Shore and Hobart's northern fringe that shares strong economic, social, and transport connections with the rest of urban Franklin, notably Old Beach has been a part of Franklin prior to 2017. Its inclusion aligns with commuting patterns where residents generally commute through Franklin. Much of Old Beach falls within the School Intake area for Lindisfarne North Primary School which is part of existing Franklin.

The Gage Brook and Swan Brook trails provides a natural land barrier for the electorate boundary between Lyons and Franklin to follow.

This change reinstates the pre-2017 boundary and aligns Franklin's northern limit with the Derwent corridor communities. The following would be transferred into Franklin:

Lyons

The electorate of Lyons is outside the 3.5% range of projected enrolment quota and requires a reduction in projected enrolment quota from 92,995 to at least the upper permissible limit of 87,516 electors.

Our submission proposes both the removal of Blackstone Heights and Prospect Vale from Lyons in the North and Old Beach from Lyons in the South. The reasons for which are addressed in the Bass and Franklin sections of this submission.

This would result in the Lyons actual enrolment remaining within the required quota range of 80,735 and the projected enrolment quota range at 83,916. The following would be removed from Lyons:

Finally for completeness the adoption of our redistribution proposal will result in all electorates being within the required permissible limits for both actual and projected enrolment and is **guided by the principle of minimal change** with our recommendations displacing less than 5% of electors across Tasmania.






